

CIBERIA TERMS & CONDITIONS

Effective Date: 6/20/2026

These Terms & Conditions ("Terms") govern your access to and use of the CIBERIA platform, including its website, mobile applications, services, and related features (collectively, the "Platform"). By creating an account or using CIBERIA, you agree to be bound by these Terms.

1. ABOUT CIBERIA

CIBERIA is a digital marketplace operated under CIBER (Caribbean Infrastructure for Business Economic Revolution), designed to facilitate commerce between buyers, sellers, and businesses through trust-enhancing features, safety tools, and reputation systems.

CIBERIA is a platform provider and, except where expressly stated, is not a party to transactions between users.

2. ELIGIBILITY

To use CIBERIA, you must:

- Be at least sixteen (16) years of age; and
- If under eighteen (18) years of age, have the consent of a parent or legal guardian.

Users under the age of eighteen (18):

- May not register as verified businesses;
- May not participate in future wallet or escrow services; and
- May be restricted from accessing age-restricted categories.

By using CIBERIA, you represent that you satisfy these eligibility requirements.

3. ACCOUNT REGISTRATION

You agree to:

- Provide accurate, current, and complete information;
- Maintain the confidentiality of your account credentials;
- Promptly update your information when changes occur; and
- Accept responsibility for activities conducted through your account.

You must not create accounts using false identities or impersonate another person or entity.

4. MARKETPLACE ROLE

CIBERIA provides a platform that allows users to discover, communicate, and transact with one another.

Unless expressly stated otherwise:

- CIBERIA does not own, inspect, or possess listed items;
- CIBERIA does not guarantee the quality, safety, legality, or authenticity of products or services; and
- CIBERIA is not responsible for the conduct of buyers, sellers, or businesses.

Users remain solely responsible for their interactions and transactions.

5. TRUST SCORES AND VERIFICATION

CIBERIA may utilize Trust Scores and verification mechanisms to enhance user confidence.

Trust Scores:

- Are based on multiple factors determined by CIBERIA;
- May increase or decrease over time;
- Do not guarantee the reliability of a user; and
- May be modified, suspended, or recalculated at CIBERIA's discretion.

Certain Trust Score events may only be influenced by ID-verified users.

Verification status may be revoked where fraud, misrepresentation, or policy violations are identified.

6. USER CONDUCT

You agree not to:

- Engage in fraudulent activity;
- Provide false or misleading information;
- Circumvent platform protections;
- Harass, threaten, or intimidate other users;
- Upload unlawful content;
- Sell prohibited products or services; or
- Use the Platform in violation of applicable laws.

7. LISTINGS AND ORDERS

Sellers are responsible for ensuring that:

- Listings accurately describe products or services;
- Prices are correctly stated;
- Orders are fulfilled in good faith; and
- Communications with buyers remain professional.

CIBERIA reserves the right to remove listings or restrict seller privileges where policy violations occur.

8. LIVE SAFETY TRACKING

CIBERIA may provide optional safety tools, including Live Safety Tracking.

By activating such features, users acknowledge that:

- Location information may be processed during active tracking sessions;
- Certain safety events may trigger administrative review;
- Safety-related investigations may occur without notice where necessary to protect users; and
- CIBERIA does not guarantee the prevention of criminal acts or emergency situations.

9. PROHIBITED ITEMS

Users may not list, offer, or sell products or services prohibited under applicable laws or CIBERIA policies.

CIBERIA reserves the right to remove prohibited listings and take enforcement action against offending accounts.

10. ACCOUNT SUSPENSION AND TERMINATION

CIBERIA may suspend, restrict, or terminate accounts where:

- These Terms are violated;
- Fraud is suspected;
- Safety concerns arise; or
- Continued access poses a risk to the Platform or its users.

Users may request review of certain enforcement decisions in accordance with applicable policies.

11. INTELLECTUAL PROPERTY

All trademarks, logos, software, and content associated with CIBERIA remain the property of CIBER or its licensors.

Users may not reproduce, modify, or distribute Platform content without authorization.

12. LIMITATION OF LIABILITY

To the maximum extent permitted by law, CIBERIA shall not be liable for:

- Indirect or consequential losses;
- Loss of profits;
- User misconduct;
- Off-platform transactions; or
- Events beyond its reasonable control.

Nothing in these Terms excludes liability that cannot lawfully be excluded.

13. DISPUTE RESOLUTION

Users agree to attempt resolution through the Platform's dispute processes before initiating formal legal proceedings.

Where disputes remain unresolved, parties are encouraged to pursue mediation prior to court action.

14. GOVERNING LAW

These Terms shall be governed by the laws of the Republic of Trinidad and Tobago.

Users are additionally responsible for complying with laws applicable within their own jurisdictions.

15. CHANGES TO THESE TERMS

CIBERIA reserves the right to amend these Terms from time to time.

Material changes will be communicated through appropriate channels.

Continued use of the Platform following such changes constitutes acceptance of the revised Terms.
